WAIVER & RELEASE: I fully understand that Jenny's Dance Centre, Inc. staff members are not physicians or medical practitioners of any kind. With the above in mind, I hereby release Jenny's Dance Centre, Inc. staff to render temporary first aid to my child in the event of an injury. If deemed necessary by Jenny's Dance Centre, Inc. staff can seek medical help, including transportation by Jenny's Dance Centre, Inc. staff member and or it's representatives, whether paid or volunteer, to any health care facility or hospital, or the calling of an ambulance for said child.

Parents should make their children aware of the possibility of injury and encourage their children to follow all the safety rules and the teacher's instructions. Jenny's Dance Centre, Inc., and it's staff members will not accept responsibility for injuries sustained by any student during the course of dance, competition or recital in which he or she may participate or while traveling to or from an event.

With the above in mind, and being fully aware of the risks and possibility of injuries, I consent to have my child or children participate in the programs offered by Jenny's Dance Centre, Inc. I, my executors or other representatives, waive and release all rights and claims for damages that I or my child may have against Jenny's Dance Centre, Inc. and or it's representatives, whether paid or volunteer. I also affirm that I now have and will continue to provide proper hospitalization, health and accident insurance coverage which I consider adequate for both my child's protection and my own. I also understand that it is the parents' responsibility to warn the child about the dangers of dance. The parent should warn the child according to what the parent feels is appropriate. Jenny's Dance Centre, Inc. will only ward the child through Safety Messages and our teaching style and progressions.

REFUND POLICY: No refunds will be given after **August 27, 2010**. There will be a \$50 service fee charged for each class refunded before the deadline.

CREDIT POLICY: Credit towards future tuition will be considered if a student suffers a serious injury or illness. Requests for medical credit must be made in writing and be accompanied by a physician's certificate. Credit is only valid for the specific student to whom it is issued.

ATTENDANCE POLICY: Students are allowed three unexcused absences per semester. Excused absences include illness accompanied with a doctor's note, funeral, one vacation day or a graded academic obligation. Please phone in all absences to the instructor, with the reason, class day and time. Failure to adhere to this policy could result in suspension from the program and/or removal from the recital.

HAZARDOUS WEATHER: Jenny's Dance Centre reserves the right to cancel classes when weather conditions become hazardous for travel. Due to limited studio space and time, canceled classes are not re-scheduled. However, students are welcome to make-up a canceled class in another class of their choice, provided it is the appropriate level and/or subject.

RECITAL AND COSTUME FEES: Recital Costume fees will be additional, \$80 per class (\$70 for Primary and Pre-Jazz) by Dec. 3, 2010, \$90 after Dec. 3, 2010. Recital Tickets will be additional (\$20) to offset recital costs.
