WAVIER & RELEASE: I fully understand that Jenny's Dance Centre, Inc. staff members are not physicians or medical practitioners of any kind. With the above in mind, I hereby release Jenny's Dance Centre, Inc. staff to render temporary first aid to my child or children in the event of any illness. If deemed necessary by Jenny's Dance Centre, Inc. staff can seek medical help, including transportation by Jenny's Dance Centre, Inc. staff member and or it's representatives, whether paid or volunteer, to any health care facility or hospital, or the calling of an ambulance for said child.

We the staff of Jenny's Dance Centre, Inc. recognize our obligation to make our students and their parents aware of the risks and hazards associated with the art of dance. Students may suffer injuries, possibly minor, serious or in nature. Dance can be dangerous and can lead to injury.

Parents should make their children aware of the possibility of injury and encourage their children to follow all the safety rules and the teacher's instructions. Jenny's Dance Centre, Inc., and it's staff members will not accept responsibility for injuries sustained by any student during the course of dance, competition or recital in which he or she may participate or while traveling to or from an event.

With the above in mind, and being fully aware of the risks and possibility of injuries, I consent to have my child or children participate in the programs offered by Jenny's Dance Centre, Inc. I, my executors or other representatives, waive and release all rights and claims for damages that I or my child may have against Jenny's Dance Centre, Inc. and or it's representatives, whether paid or volunteer. I also affirm that I now have and will continue to provide proper hospitalization, health and accident insurance coverage which I consider adequate for both my child's protection and my own. I also understand that it is the parents' responsibility to warn the child about the dangers of dance. The parent should warn the child according to what the parent feels is appropriate. Jenny's Dance Centre, Inc. will only ward the child through "Safety Messages" and our teaching style and progressions.

REFUND POLICY: No refunds will be given after June 14, 2010. There will be a \$50 service fee charged for each class refunded before the deadline.

CREDIT POLICY: Credit towards future tuition will be considered if a student suffers a serious injury or illness. Requests for medical credit must be made in writing and be accompanied by a physician's certificate. Credit is valid only for the student to whom it is issued.
